CHAIR'S REPORT

This year the board started the year with a "Board Retreat and focussed on reviewing our strategic plan and updating and expanding our policies and procedures. This process continued throughout the year, to ensure we conform to all regulations as a non-profit entity. Last year, I reported that ADK uses technology as an enabler to meet ADK's goals and objectives. ADK continues to invest in social media, providing a platform for parents to communicate and learn from each other. CEO REPORT

Looking back on the year, the vivid moments are the messages that parents of newly-diagnosed babies post to one of our groups and the cascade of messages of support and encouragement they receive from other parents - letting them know that they have found a safe place to ask questions, learn from each other and share the ups and downs along the way. It makes this all worthwhile.

Sometimes it can feel that the voice of consumers is not heard in the cacophony of news and policy decisions, but we seem to have made some headway over the past year. There has been genuine collaboration between consumer groups and government departments to build services and systems that meet the needs of consumers – people with hearing loss and their families.

I was honoured to be invited by the Minister for Aged Care and Minister for Indigenous Health, Mr Ken Wyatt AM, MP, to join the Hearing Health Sector Committee as a representative of parents raising children with hearing loss. The Committee, in collaboration with the Australian Government, will develop a Roadmap of Hearing Health which is anticipated to improve hearing health for all Australians.

We have a couple of big projects planned for the coming year. We are trialling a few webinars for parents to be made available on our website. While we have been unable to attract funding, we are planning on developing a comprehensive suite of NDIS-related information resources that are specific for children who are deaf and hard of hearing over the coming year. We are also planning another Parent Conference to bring together parents and professionals so we can learn from each other.

I have agreed to continue as Co-Chair of the Global Coalition of Parents of Children who are Deaf or Hard of Hearing (GPODHH). This has been an incredible experience and helps to provide some perspective to the issues families around the world face when their child is diagnosed with hearing loss. In July 2018, Aussie Deaf Kids funded two parents to represent GPODHH at the 3rd Stakeholders' meeting for the WHO programme on prevention of deafness and hearing loss in Geneva, Switzerland. As an international parent group collaboration, we are continuing to work with the WHO as they develop the World Report on Hearing due in 2020.

Thank you to our small team of committed individuals, our collaborators, our generous donors and parents in Australia and around the world for your ongoing support and interest in Aussie Deaf Kids. We couldn't do this without you.



Opinion
