CHAIR'S REPORT

I am privileged to submit the annual Chair's Report on behalf of the board of Aussie Deaf Kids.

It has been an exciting year for ADK. We started the year off at our annual board retreat evaluating our direction, succession planning and the organisation's sustainability. One major concern was our ability to attract funds, which continued to prove elusive. I am pleased to report that early this year ADK was successful in securing a government grant to build its individual and organisational capacity. This grant allowed us to commence two projects. The first project - developing a course for parents on decision making - and the second focused on improving the organisation's ability to communicate effectively and manage its membership. ADK was able to engage two short-term contractors to help with these projects. Both projects are well underway and scheduled for completion before the middle of next year.

I recently had an opportunity to be involved in an audiological training course for New Zealand. As part of the course's development, we interviewed a parent advocate. These advocates are funded to support parents/caregivers of deaf and hearing-impaired children. They provide one-on-one support for new parents, guiding them through the often challenging decisions for their child's education, medical and emotional needs. I thought it is a great initiative. Here in Australia, we have organisations like Aussie Deaf Kids who can help parents to make informed decisions for their kids too.

Our CEO, Ann Porter continues to advocate for parents of deaf and hearing-impaired children and will represent us at the upcoming World Health Organisation conference in Geneva, on behalf of GPODHH (Global Coalition of Parents who are Deaf or Hard of Hearing). I congratulate Ann on writing the successful grant application for our recent funding. On behalf of the board, I thank Ann for her leadership and dedication throughout the year.

I would personally like to thank our CEO, staff and board members for their time, skills, leadership and guidance. I would also like to thank our Auditors, StewartBrown, Chartered Accountants for their generosity in providing auditing services to ADK in 2019.

I look forward to continuing to work with our Board, CEO, staff and volunteers in the year ahead.

Stephen Pascoe Chair It has been a year of re-evaluation for Aussie Deaf Kids as we look at future directions and the sustainability of the organisation. Two events have changed our traditional focus of online support and information – receiving a grant from the National Disability Insurance Agency (NDIA) and the inclusion of GPODHH in the World Hearing Forum.

Aussie Deaf Kids has prided itself on delivering balanced and reliable information for parents whose child is deaf or hard of hearing since we registered as a not-for-profit organisation in 2007. The reason for this is, so families are better able to make informed decisions about different aspects of their child's life. We were, therefore, delighted to receive a grant from the NDIA to develop an online course for parents about making informed decisions. Flora Chan, who has a son with hearing loss, is managing the project for us. We are excited at how things are coming together and look forward to making it available to parents by mid-2020.

The same grant included a component for organisational capacity building, and Rachel Freeman has taken on that role for us. The miracle of the Internet – Rachel is in Tasmania, Flora in Melbourne, our web developer in Cairns, and me in Brunswick Heads. Bec White, our social media coordinator, lives in country Victoria and our board are scattered around Victoria and NSW. We have been able to collaborate and communicate seamlessly using a variety of methods and online platforms. This significantly reduces our costs and allows us to engage the right people working from the convenience of their own homes.

A large amount of my time this past year has been spent on activities related to my position as Vice-Chair of the Global Coalition of Parents of Children who are Deaf or Hard of Hearing (GPODHH). Aussie Deaf Kids is a founding member of GPODHH - a coalition of parent-led groups from around the world committed to the principles of family-centred practice, parent-to-parent support, and the inclusion of parents as partners in services and system development, design and improvement. Each group volunteers their time to deal with GPODHH business, but the organisation itself does not have independent funding.

GPODHH has been invited to attend the World Hearing Forum (WHF) in Geneva and Aussie Deaf Kids will assist two parent leaders from low-income countries in attending the meetings and providing the parent voice when decisions about hearing health throughout the world are made at the World Health Organisation. The World Hearing Report will be published in March 2020. This is a crucial document for families with deaf and hard of hearing children, particularly in developing nations, and we want to ensure that formal and informal supports for families are included. We also hope to highlight the issue of abuse of neglect of deaf children and the importance of implementing measures to protect their safety, wellbeing and human rights to live free from abuse, harm and neglect. It has been a privilege and an inspiration to work with so many parent leaders making a difference for families in their home countries and communities.

The challenges faced by families in other parts of the world when their child is identified with hearing loss, illustrates how fortunate children and their families in Australia have been over decades. Babies are identified early and receive timely, expert and free audiology and early intervention through the National Disability Insurance Scheme. But for most families, the diagnosis of their baby' hearing loss remains a difficult period of adjusting to the new reality of a different life than they had anticipated. It can be a huge learning curve and an emotional rollercoaster. Our online parent-to-parent groups provide some of the information and emotional support that parents need through different stages of their child's life – informal support that is so important for child and family wellbeing.

I want to thank the board. Each contributes their time and expertise to assist me. Steve Pascoe – our computer expert – is pivotal to our online operation. Michael Allen and Bruce Porter – both economists who keep an eagle eye on our scarce financial resources, Jill Duncan and Ros Wyburn with their extensive knowledge and lived experience who help with submission and grant writing and provide a listening ear and sage advice. I would not be able to manage without their support. Thank you all!
